Moonlight Walk 2025 Terms and Conditions

1. To take part in The Moonlight Walk, you must agree to all terms and conditions, complete the online entry form and pay your entry fee.
 2. The entry fee is non-refundable as it helps to cover the cost of the event and is not treated as a donation.
 3. You understand that this is a fundraising event, and you pledge to raise as much sponsorship as possible, or to make a personal donation in addition to the entry fee. The money raised must solely be in aid of Treetops.
 4. Donations (including sponsorship money) are given without restriction or designation. This allows Treetops to use your gift where need is most.
 5. Any activity is undertaken at your own risk. You are responsible for ensuring you have sufficient fitness and health to take part in the event. Treetops Hospice can accept no liability before, during or after this event for:
 - any injury, loss or damage caused or sustained due to taking part in the event.
- any property lost or damaged due to taking part in the event.
6. You understand that walking along public roadways at night is potentially hazardous. Whilst the route is fully marshalled, you are still personally responsible for abiding by The Highway Code.
 7. You must follow the instructions of the marshals, security and medical staff at all times.
 8. You must sign in at the venue before completing the walk and sign out on completion of the walk.
 9. Those under the age of 18 must be accompanied by an adult who has entered the event and takes full responsibility for you.
 10. If you are an adult accompanying someone under the age of 18 years you must take full responsibility for them, ensuring they are fit and well and able to take part in the event, behave appropriately and are always safe.
 11. We ask you to walk the route and not stop off any unofficial points along the walk for instance pubs, cafes or homes.

- 12.No alcohol should be consumed on the walk. There will be alcohol available to purchase at the venue, but all participants should ensure that they are fit to walk the route. Anyone deemed unfit to participate will be removed at the organiser's discretion.
- 13.No dogs/animals can be taken on the walk except assistance dogs.
- 14.Photographers will be taking photographs and videos throughout the event. By accepting these terms and conditions, you are granting Treetops Hospice full rights to use the images resulting from the photography/video filming for both this campaign and future campaigns. This might include (but is not limited to) the right to use them for printed and online publicity, press releases and funding applications.
- 15.In the event of adverse weather conditions or circumstances that would jeopardise the safety of those taking part, the event may be cancelled at short notice.
- 16.In the unlikely event of cancellation, registration fees are non-refundable.
- 17.The organiser has discretion to remove anyone acting inappropriately from the walk.
